Terms and Conditions

Members Draw and Second Chance Draw

Maroochy River Golf Club

1. Promoter

The promoter is Maroochy River Golf Club Ltd. The promotion is conducted in accordance with applicable Queensland legislation and the Club's approved gaming and promotional permit conditions.

2. Eligibility

- Entry is open to current Full Financial Members of Maroochy River Golf Club who are aged 18 years or over.
- The following persons are not eligible to participate or win:
 - All Club employees
 - Board members and their spouses
 - Junior members
 - Honorary members
 - Wait list persons
 - Any person excluded from the Club or suspended from membership
- Ineligible persons will be removed from the Members Draw database.

3. Members Draw Details

1. The Members Draw is conducted every Friday at 7:30pm.
2. The Members Draw commences at \$1,000 and increases by \$100 each week if not won.
3. The jackpot is capped at a maximum of \$8,000.
4. Once the jackpot reaches \$8,000, it will remain at \$8,000 until won, subject to clause 3.10.
5. Eligible members are automatically entered into the Members Draw via the Club's membership database. No swipe or manual entry is required.
6. One membership number will be randomly selected from the database at each draw.
7. The selected member must be present within the Club's licensed premises at the time of the draw.
8. The selected member must claim the prize within one minute of their name being announced via the Club's public address system.
9. If the prize is not claimed within the required timeframe, the prize will be forfeited.

4. Second Chance Draw

1. If the Members Draw prize is not claimed, a Second Chance Draw will be conducted for a \$100 MRGC Cash Card.
2. To be eligible for the Second Chance Draw, members must:
 - Swipe their membership card at the front desk between 5:00pm and 7:00pm on draw nights
 - Receive a ticket upon swiping
 - Place the ticket into the designated barrel
3. Only tickets issued on valid draw nights are eligible for entry.
4. One ticket will be drawn for the Second Chance Draw prize.

5. Monthly Guaranteed Draw

1. All valid Second Chance Draw entries will remain in the barrel until the first Friday of each month.
2. On the first Friday of each month, following the conclusion of the Members Draw, one ticket will be drawn to win a guaranteed \$500 cash prize.
3. The selected member must be present within the Club's licensed premises at the time of the draw.
4. If the selected member is not present, additional tickets will continue to be drawn until a present and eligible member is identified.
5. Once a present and eligible member is identified, the \$500 cash prize will be awarded on the night.
6. Following the monthly guaranteed draw, all entries will be cleared and a new entry period will commence.

6. Payment of Prizes

1. Members claiming a prize must identify themselves to the reasonable satisfaction of the Club, including providing valid photo identification if requested.
2. All Members Draw cash prizes will be paid via electronic funds transfer to the winning member on the Monday following the draw.

4. MRGC Cash Cards are not redeemable for cash and are subject to the Club's standard Cash Card terms of use.

3. The Club reserves the right to verify eligibility and disqualify any participant who does not comply with these Terms and Conditions.
